APRIL IS LINEMAN APPRECIATION MONTH

he Merriam-Webster dictionary defines appreciation as a feeling or expression of admiration, approval, or gratitude. I would like to take this opportunity to appreciate and thank our line crews at Highline Electric Association.

My appreciation for our line crews begins with something I take for granted. In my lifetime, I can count on one hand the number of times I have had to endure a power outage that lasted more than 24 hours. That kind of reliability creates expectations. I have come to expect my power to be on and available, all the time, with very few exceptions.

Power outages, when they do occur, result from a variety of causes. The outages experienced across the Southwest Power Pool and Texas in February were of a regional nature. These large regional outages are due to circumstances that are largely outside of our control. The February example was due to extremely cold temperatures across a large swath of middle America. The cold temperatures created unusually high energy demands as those affected tried to keep their homes warm. At the same time, power generation resources were failing: the wind was not blowing, the sun was not shining, and increased demand for natural gas by heating customers resulted in an interruption in gas supplies to power generators, tripping gas generation units offline.

The majority of the outages we experience at Highline, however, are of a local nature. Thunderstorms roll across our service territory resulting in lightning damage to equipment. The same thunderstorms can pack powerful straight line or

tornadic winds that can snap poles off and leave conductors a tangled mess. Powerful winter storms can produce similar wind damage. But, without a doubt, the combination of ice and wind creates the most dreaded outage causing combination across our service territory. Freezing rain accumulates on conductors adding weight and surface area to the conductor. Icing conditions, followed by high winds will wreak havoc on an electric distribution system. It is during our line crew's response to these outage conditions that I cannot help but appreciate the dedication of these unique individuals.

Line work remains a high-risk occupation, even though we continually emphasize safety and training. Linemen risk falls, electric shocks, burns and other injuries while on the job every day and these risks are amplified during adverse weather conditions.

It is for these reasons we honor our line crews by observing Lineman Appreciation month each April. When I am at home with my family during a nasty winter storm; when the wind is blowing 40 miles an hour, the visibility is near zero from blowing snow, and it is 10 degrees outside; and my power goes out in the middle of the night I take a moment to pause. I take a deep breath and try hard not to be annoyed by how inconvenienced I am going to be by this power outage and appreciate the crew that has traversed roads that were more than likely next to impassable, to locate the problem and work 25 feet in the air to restore my power.




